Reports

Secretary's report

Jenn made a motion to approve the 12/09/25 minutes, Mitty seconded. No discussion. 6 yes, no abstentions. Motion carries.

Treasurer's Report

Mitty made a motion to approve the Treasurer's Report and place it up for audit, Thea seconded. No discussion; 6 yes, no abstentions. Motion carries. Jenn said that Amazon wasn't listed on the Expense Report and that Dan will take another look at it. We looked into the Park Street Foundation line item and found that it is the annual subscription to e-books for Libby (via NH Downloadable Books). Mitty made mention that we should be charging the out-of-town memberships since they are not tax payers. Barry said he would start doing that.

Section IX - Holiday, Paid Time Off (PTO), and Leave Policy

Edited the title from Personal Time Off to Paid Time Off. Discussion re: whether or not to add Junteenth to the list of paid holidays. Jeny Levisee sent a message to Jim Tetreault to find out if the Town Hall closes on June 19th. He said the town does not close. Barry said that he feels we should close because it reflects our values and he has had someone ask him why we were open because it's a national holiday. We decided to add it to the list of paid holidays and if we receive pushback for being closed then we will have another conversation about it. Ann will edit "Columbus Day" to "Columbus Day / Indigenous Peoples Day." Discussion re: Paid Time Off policy on retirement ("upon separation"). Changed it to "after sixty (60) days of separation" instead of "after sixty (60) days notice." In section "I. Bereavement Leave," we changed "personal time" to "paid time." We changed the Jury Duty section to say that they will get paid if it's a day that they would already be working. Jenn made a motion to accept Section IX of the Policy Manual after amendments are made. Thea seconded. 6 yes, No abstentions. Motion carries
